1. Product Description

Potatoes are a versatile food crop and can be processed into a wide variety of products. Potatoes are also used in many commercially produced products such as potato chips, mashed potato flakes, and instant potatoes. In addition to being used as food, potatoes are also used for industrial purposes, such as in the production of alcohol, glue, and starch.

The Harmonized Commodity Description and Coding System (referred as HS Codes) designated for international trade of Potatoes can be seen in the following table:


2. Global Trade of Potato and Value-added items

Potatoes are one of the most valuable and important commodities in international trade. During the year 2021, the international trade value of the Potatoes and its value-added products were US\$ 16.6 Billion. The exports have shown a mixed growth trend with an average growth rate of 4.31 % from the year 2017 ~ 21. The last five years' exports of Potatoes and value-added items in global trade are as follows:

By examining the export statistics of potatoes and their value-added products over the last 5 years, it becomes apparent that Frozen Preserved Potatoes are the most exported item, followed by Fresh/Chilled Potatoes and Unfrozen Preserved Potatoes.




Figure 2: Growth Trend of Global Export of Potatoes and Value-added Items (Value US \$ Million)

The graph above shows the trend of global export of potatoes and value-added items of potato. The decline in the year 2020 may be mainly due to Covid-19 among other factors.

Top Exporting Countries of Potatoes and Value-added items

Major Exporters of Preserved Potatoes Frozen (HS 200410)

During the last 5 years, the exports of Frozen Preserved Potatoes have been dominated by Belgium, followed by Netherland and Canada. The percentage share of top exporting countries for this product category is given in the following table:

Major Exporters of Fresh/Chilled Potatoes (HS 0701)

During the last 5 years, the exports of Fresh Potatoes have been dominated by Netherlands, followed by France and Germany. The percentage share of the top exporting countries is given in the following table:

As can be seen in the table above, that Pakistan ranks at 11th in export for this category of product during the year 2021.

Major Exporters of Preserved Potatoes Unfrozen (HS 200520)

During the last 5 years, the exports of Unfrozen Preserved Potatoes have been dominated by Netherlands, followed by Belgium and USA. Pakistan ranks 52nd in terms of exports for this category of the product. The percentage share of the top exporting countries is given in the following table:

3. Pakistan's Import and Exports Statistics of Potatoes and Value-added Items

Pakistan exported fresh/chilled potatoes worth US \$501 million to the world during 2017-2021 and imported US \$47.11 million during the same time period. It is worth noting that the majority of potatoes are imported for the purpose of seed planting. Regarding value-added potato products, Pakistan is not substantially exporting. However, the import of such items is high due to the lack of potato processing facilities in Pakistan. Details of these products can be seen in the following graph.


Pakistan is one of the major exporting countries of Potatoes with availability of high-quality Potatoes. Over the years, export figures have shown positive growth with slight decline in last couple of years with an average growth rate of 14% from the year 2017 ~ 21. Pakistan's last five years' export figures of Potatoes are as follows:



The above chart shows imports and export of potato and value-added products of potato from Pakistan. Pakistan export large quantities of fresh potatoes, while there is no export in preserved potatoes frozen, potato starch, potato powder, potato flakes etc. Similarly, Pakistan imports large quantity of fresh potatoes as compared to other categories.

Pakistan's Export Destinations for Fresh Potatoes

4. Import Destinations of Potatoes and Value-added Items

Fresh / Chilled Potatoes and Seed Potatoes

The largest importing country of fresh potatoes is Belgium, followed by the Netherlands and the USA. Additionally, Belgium is also the top importer of seed potatoes in the world. The following graph provide further details on the top importing countries for fresh and seed potatoes. It's worth noting that Pakistan stands at 15th place in terms of seed potato imports.





Figure 4: World Top 5 Importers of Fresh Potatoes (Trade Value in US \$ Million) - 2021





Figure 6: World Top 5 Importers of Potato Powder, Flakes, etc. (Trade Value in US \$ Million) - 2021







Figure 9: World Top 5 Importers of Preserved Potatoes Frozen (Trade Value in US \$ Million) - 2021

5. Pakistan's Export Trade and Tariff

Customs Tariffs/Duties

Knowing customs duties (or tariffs) are important to take decision of choosing a product or service for import or export economically feasible or not. In the same manner to claim refund or rebate again knowing custom duty is essential. Whole circle of import and export depends upon knowing and using the custom tariffs/duties or exemptions. Determining which customs duty is applicable to a product is a complex exercise and expert advice may be sought. Customs Act, 1969, Customs Rules 2001 are the relevant law and Pakistan Customs under FBR is the only authority to deal with custom tariffs and rules. Government often changes duty structure and rules due to which these are not stagnant. Following is the link to check the customs tariffs/duties applicable in which Pakistan Customs is the final authority to the extent of Pakistan.
