2. Introduction to SMEDA

3. Introduction to Leather Sector

The objective of this short write-up is to provide the reader with an overview of the sector. The information covers global trade of leather products, status of Pakistan's exports and summary of industry structure. Trade information for global comparisons has been obtained from www.trademap.org, International Trade Centre's Database.

Leather and leather products are some of the most widely traded products globally. It is estimated that international leather trade exceeds US\$ 80 billion annually, and this figure is expected to continue growing with increasing population and urbanization of developing and countries.

The production and supply of leather products has gradually moved from industrialized to developing and emerging economies. Many emerging economies can now manage the whole supply chain on their own and are fast becoming important suppliers of value-added finished products. For example, about 45% of footwear is made in China.

Pakistan, because of its large livestock resources, has remarkable growth potential in the leather sector. Unfortunately this potential remains mostly untapped due to the following reasons:

- lack of technical know-how
- Lack of access to information
- visibility
- In effective quality management,
- Poor Marketing
- Lack of investments
- Insufficient international industrial alliances

The leather industry of Pakistan is the second biggest export-oriented industry in the manufacturing sector and is third in its contribution towards the overall exports of Pakistan. The leather industry's core products in Pakistan are leather jackets, leather gloves, leather bags, leather garments, tanned leather and footwear.

3.1. HS: Code Listing

The Harmonized System (HS) is an international nomenclature for the classification of products published by the World Customs Organization (www.wcoomd.org). It allows countries to classify traded goods on a common basis for customs purposes

It can be seen that the major value contributor in Pakistan's leather sector exports is product category HS: 4203 which represents Leather Apparel. For HS codes reflecting 0%, please note that the values are rounded down and form a negligible portion of the Product Mix.



In this section we will be looking at global trade of a subsector in leather, namely leather footwear and how Pakistan plays into it.


To study trade in leather footwear sector, we will focus on product HS codes 6403 and 640420, further described below;

5.1. World Exports

The total world exports for leather footwear HS 6403 stood at USD 56,101,435 thousand million (\$56,101 million) in the year 2019. Similarly, total world exports for HS: 640420 in 2019 stood at USD 950,277 thousand (\$0.95 million).






5.2. Major Import Markets

Total value for world imports of leather footwear HS: 6403 was USD 55,362 million in the year 2019. United States is the largest importer of leather footwear by a significant margin, spending more than USD 11,317 million in 2019. Germany, France, Italy and the United Kingdom also fall in top five importers of leather footwear. Details on the value of Leather footwear imports for top five importing countries, along with percentage growth from 2018 to 2019 in this category are given in table below;

The following illustration demonstrates dollar value spent by top five importers of leather footwear HS: 6403 from 2015 up to 2019.





5.2.1. Major Importers Market Share

As mentioned before, USA is the largest importer of leather footwear (HS: 6403 as well as HS: 640420). Based on data for the year 2019 USAs share in world imports of leather footwear HS:6403 is 20.4%, while, Germany, France, Italy and the UK account for 9.7%, 6.9%, 5.6% and 5.4% respectively. Pakistan typically does not Import any significant quantity of products that come under the leather footwear category. This is possibly due to the availability of cheap locally produced leather footwear items. The table below, and the accompanying pie chart show shares of top leather footwear importers, with reference to total world imports.

6. Pakistan

6.1. Pakistan's Exports

Pakistan's share in global exports of leather footwear is around 0.2% as of 2019. Considering that there is abundance of good quality leather available in Pakistan, this figure is very low. With calculated investments in this sector focusing on areas like technology and skill improvement, coupled with well-planned businesses decisions, Pakistani businesses should be able to produce and export in significantly larger volumes.
