After the 8th amendment every province has its own health care rules and regulations. This document provide the licensing requirements of medical store in Punjab.

5. Relevant Law

The Pakistani laws that deals with License of medical store are as following:

- Punjab Drugs Act, 1976 (XXXI of 1976)
- Punjab Drug Rules 1988
- Punjab Drugs Rules 2007

6. Relevant Authority for Application For License of Medical Store

Under **Rule 2(g)** Punjab Drug Rules 2007, The Secretary to the Government of the Punjab, Health Department is the Licensing Authority or any officer of the government duly authorized by the secretary Health. However, he has delegated his powers to Executive District Officer (Health) at District level for public convenience, speedy and timely disposal of Licenses.

7. Background

Procedure for starting a medical store depends in which province the medical store is going to be opened because as per the 18th amendment of the Constitution of Pakistan 1973 health is a provincial matter and every province have its own Drug Regulatory Body and stipulates the law and rules for obtaining license for medical store.

In the subject document we are providing legal requirements and procedure for obtaining a license for medical store in the province of Punjab.

8. Relevant Offices in Punjab for the Submission of Application for Drug Sale License

Application for medical store or drug sale may be submitted physically or online but in both the cases applicant need to visit the following relevant office:

9. Eligibility Criteria

Doctor of Pharmacy, Five years degree holder is required for registration as a Pharmacist for opening of a medical store, however, any person can apply for license but he\she has to show hiring or appointment of a pharmacist or a qualified person (Dispenser) to run the medical store.

Note: It is important to verify the registration of the qualified person from the office of Punjab Pharmacy Council before applying the license of medical store from the office of Executive District Officer (EDO) Health – Punjab.

Any medical organization that desires to recruit any pharmacist/pharmacy assistant/pharmacy technician may verify his registration and related status from the office of Punjab Pharmacy Council to know the genuineness.

Fee for any kind of verification shall be submitted in the form of Bank Draft for PKR 500 in the name of Secretary, Punjab Pharmacy Council.

11. Types of License for Sale of Drugs

The licenses are of four types

License No.9. For retail sale.

License No.10. For wholesale.

•License No.11. For sale of narcotics, and other controlled drugs.

•License No 12. For establishment of Pharmacy. (Only issued to Graduate Pharmacist registered in Category-A).

Note: (Persons convicted for the sentence one year or more or sentenced to pay fine Rs. 30,000/- or more under section 27(1) of the Drug Act 1976 are not eligible for the grant of License.

12. Procedure for Application

As per rule 15 Punjab Drug Rules 2007, a person may apply for the grant or renewal of a license for sale of drugs to the licensing authority in the prescribed form 8 (A) and 8 (B)*1.

15. Sale at More than One Place

As per **rule 17 of Punjab Drugs Rules 2007**, separate License for each place is required for opening of more than one medical store or pharmacy. However, for storage purpose separate license is not required.

16. Duration of License

Duration of License is almost two year unless suspended or cancelled earlier. License expires on every 31st day of December of calendar year. Renewal application may be submitted within 60 days from the expiry date.

17. Documents need to be attached with the Application for License

- i. Original receipt of fee deposited in the head account
- ii. Original certificate of pharmacist or dispenser with Punjab Pharmacy
 Council
- iii. Attested copy of CNIC of the applicant

- Attested copy of CNIC of the qualified person who's certificate is being used
- Four passport size latest photographs of applicant and the qualified person
- vi. Attested copy of the rent deed or ownership of the premises
- vii. Affidavit of applicant and the qualified person
- viii. Location map of shop and go-down.
- ix. Bank draft of Rs.50/- for verification of dispenser certificate (if applicable).
- x. Purchase receipt of Refrigerator.

18. Conditions for Issuance of License

Form 9 or Form 10 (License) will only be issued if the following requirements are fulfilled:

- i. The premises has proper and adequate facility for storage of drugs and for their protection from direct sunlight, dust or dirt, including refrigeration facility;
- ii. The premises is clean, hygienic and in tidy condition;
- iii. The covered area of the premises of a pharmacy is not be less than 140 square feet with minimum breadth of 8 feet in the front and height of 8 feet and in case of a medical store, 96 square feet with minimum breadth of 8 feet and height of 8 feet.

7-In case of satisfaction under the rules regarding cleanliness and measurement license will be issued for the period of two (2) years.
