2.Terms of Lease:

- **2.1 Lease Term:** The lease term will begin on [Start Date] and end on [End Date]. This agreement may be extended (if required) with the mutual consent of both the parties in writing.
- **2.2 Lease Money:** The party B agrees to pay the party A, a total lease money of Rs. [Lease Amount] for the entire lease term, payable in

- **2.3 Use of the Land:** The party B shall use the land solely for agricultural purposes, including but not limited to [Specify the types of crops or livestock allowed]. The party B shall not use the land for any other purposes without prior written consent from the party A.
- **2.4 Maintenance and Repairs:** The party B shall maintain the land, including fences, irrigation systems, and any other improvements, in good working condition. The party B is responsible for all necessary repairs and maintenance during the lease term.
- **2.5** Access to the Land: The party A shall have the right to access the land for inspection and other lawful purposes, provided that reasonable notice is given to the party B.
- **4.Termination:** Either party may terminate this agreement with written notice of [Notice Period] days. In the event of a breach of this agreement by either party, the non-breaching party shall have the right to terminate this agreement immediately.

Each party shall pay its own costs and disbursements of and incidental to this Agreement and the transactions contemplated hereunder.
