2 Introduction of SMEDA

Small and Medium Enterprises Development Authority (SMEDA) is an apex SME development agency working under the Ministry of Industries and Production (MoI&P), Government of Pakistan. In pursuit of its mission, SMEDA has adopted an integrated strategy that comprises SME sectors & clusters development, Business Development Services (BDS), and Policy advocacy to protect and promote SME interests. SMEDA offers a broad spectrum of business development services to SMEs which include prefeasibility studies, identification of experts and consultants, delivery of need-based capacity building programs in addition to business guidance through help desk services along with other initiatives of SMEDA for SME development.

3 Purpose of the Document

This document is a demonstrative guide for business community who are interested in getting electricity connection for their industrial and commercial units, particularly for businesses categorized as Small & Medium Enterprises (SMEs). The guide aims at helping to understand the procedure of getting electricity connection.

4 Relevant Law & Authority

In order to promote fair competition in the electricity industry and to protect the rights of customers as well as producers and sellers of electricity, the Government of Pakistan has enacted the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

The National Electric Power Regulatory Authority (NEPRA), has been established under this Act for regulation of electric power generation, transmission and distribution in Pakistan. NEPRA has an objective to provide growth to the electric power sector and to rationalize the electricity rates. NEPRA is also to ensure that investment in the electricity industry is justified and earns a reasonable return for the investors.

WAPDA, the relevant authority for electricity connection was established in 1958 and its agenda includes generation, transmission and distribution of power. It is also responsible for irrigation, water supply and drainage flood control, internal navigation etc.

WAPDA's distribution network is divided into various electric supply companies structured in line with modern management practices:

- 1- Lahore Electric Supply Company (LESCO)
- 2- Islamabad Electric Supply Company (IESCO)
- 3- Multan Electric Power Company (MEPCO)
- 4- Faisalabad Electric Supply Company (FESCO)
- 5- Gujranwala Electric Power Company (GEPCO)
- 6- Sukker Electric Power Company (SEPCO)
- 7- Peshawar Electric Supply Company (PESCO), Catering KPK Province
- 8- Quetta Electric Supply Company (QESCO), Catering Baluchistan Province
- 9- Hyderabad Electric Supply Company (HESCO), catering Sindh Province except Karachi
- 10- Tribal Electric Supply Company (TESCO), Working under the administration of CE, PEPCO to cater the needs of Tribal Areas

5 Types of Connections Available

WAPDA is providing three types of connections, according to the purpose and extent of usage of electricity. These categories are as follows:

- i. Domestic (A-1)
- ii. Commercial (A-2)
- iii. Industrial (B-1, B-2)

The applicants are divided into these categories on basis of the purpose for which electricity is being used. The applicants requiring connection at their residences are classified as 'Domestic (A-1)' consumers. The applicants requiring connection for usage at their business sites are termed as 'Commercial (A-2)' consumers, such as hotels, and restaurants etc. If the applicants require the electricity connection at their place of business and are utilizing

electricity for the purpose of operating heavy machinery for production, they are categorized as 'Industrial (B-1, B-2)' consumers.

6 Electricity Connection for Agriculture

The procedure of getting electricity connection for agriculture is same as for industrial. Agriculture related consumers are required to apply for / select the appropriate connection based upon their load capacity. Electricity tariffs for agriculture sector are different from that of Industrial, therefore, even though the type of connection will fall under "Industrial (B-1, B-2)" at the time of application, bill generated thereof will have "Agriculture" mentioned on it.

7 Documents Required

Documentation requirement for electricity connections is dependent upon load capacity required for which the application is made and the type of connection as referred above. Documents required for a sole proprietor, firm or company applying for any one type of connections, i.e. A-1, A-2, B-1, B-2, have been listed below:

- 1- Application Form
- 2- Abridged Conditions of Supply
- 3- Attested Copy of National Identity Card of Applicant
- 4- Attested Copy of National Identity Card of witness
- 5- Attested Copy of Property Ownership
- 6- NOC from Owner in case of Tenant

Following additional documents are required for Industrial Connection in case of a Limited Company:

- 1- Resolution from Board of Directors in Favor of Signatory
- 2- Addresses and attested copies of CNIC of all Board Members.
- 3- Certified True Copy of Memorandum of Articles of Association
- 4- Certified True Copy of Form-29
- 5- NOC from all Directors as per Form 29

8 Sanctioning Officers for Connections

The sanctioning authority is responsible for inspection and processing of documents. The sanctioning authority varies with the load of the energy being consumed.

8.1 Domestic and Commercial Connection: A1, A2

LOAD	SANCTIONING OFFICER
1-15 KW	Assistant Manager Operations (AMO)/SDO
16-70 KW	Deputy Manager Operations (DMO)/XEN
70-500 KW	Manager Operations (MO)/SE
500 and above	Chief Executive (CE)

8.2 For Industrial Connection: B1, B2

The sanctioning authorities for the industrial connection are different from the domestic and commercial connections and are stated as below:

LOAD	SANCTIONING OFFICER
Up to 70 KW	Deputy Manager Operations (DMO)/XEN
70-500 KW	Manager Operations (MO)/SE
500 and above	Chief Executive (CE)

9 Estimated Time Schedule

Time required to process an application for electricity connection depends upon the type of connection and begins from the date of registering the application to installation of the connection. For detailed information regarding time schedules please refer to Annexure III.

10 Step Wise Procedure for Commercial and Industrial Connections:

All the new applications for electricity connections are processed through Electricity New Connection (ENC) System, www.enc.com.pk for all distribution companies except KE.

This section will facilitate you with the procedure for getting new electricity connection from distribution companies.

Note: Karachi area is separately administered under K-Electric and has its own procedure of connection and tariff rates; however, K- electric has agreement with WAPDA as electricity supply is a federal matter. Website: www.ke.com.pk.

The following steps must be followed

Step #1	Fill the online Application Form (For Offline Form, refer to Annexure-I)
Step #2	<p>Please upload the scanned copies of the following documents. Make sure that the size of scanned documents are less than 50 Kilo Bytes:-</p> <p>(a) Proof of ownership (Registry, Actual Farred, Baynama, Allotment Letter (In case of Housing Colony). All pages duly attested by Oath Commissioner or Notary Public or Class one officer.</p> <p>(b) Undertaking by the Applicant (As per the specimen available in the concerned office on Stamp Paper duly attested by Oath Commissioner) that no electricity connection is previously available on the required connection place and no arrears exists. If arrear found on latter stage, I shall bound to pay them.</p> <p>(c) In case of more than one owner, power of attorney (As per the specimen available in the concerned office on Stamp Paper duly attested by Oath Commissioner) in favor of applicant from other owners.</p> <p>(d) In case of applicant is a tenant, No objection certificate (As per the specimen available in the concerned office on Stamp Paper duly attested by Oath Commissioner) from the owner of the property.</p> <p>(e) Attested copy of CNIC of the applicant.</p> <p>(f) Attested Copies of CNIC of the two witnesses (in case of single phase meter witnesses are not required)</p> <p>(g) A copy of concerned Tariff duly signed by the consumer and witnesses (In case of Domestic and Commercial connections, signatures of the witnesses are not necessary).</p> <p style="text-align: center;"><u>Additional documents only for industrial applicants</u></p> <p>(h) Connection in the name of Company and in case of more than one owner , Power of Attorney (in the favour of Applicant) that he can follow the application and also sign contract with the Distribution Company.</p> <p>(i) Site map where connection is required.</p> <p>(j) In case of Limited or Private Limited Company, copy of incorporation certificate (Article and memorandum of Association).</p> <p>(k) Complete addresses and attested copy of CNIC of all board of Directors.</p> <p>(l) No Objection Certificate on Company letter head as per Form 29 duly signed by all the Directors of the Company.</p> <p>(m) Charge Creation Certificate from Security and Exchange Commission, whose worth will be equal to the security amount.</p>
Step #3	Submit the online Application Form
Step #4	Get Printout of the Application Form
Step #5	Attach all above documents with Application Form
Step #6	Send Application along-with all attachments to the concerned office
Step #7	After verification of the documents, Demand Notice will be issued
Step #8	Please pay the Demand Notice to the designated bank
Step #9	Please send paid Demand Notice copy to the concern office
Step #10	After verification of Demand Notice payment, connection will be installed






