3. ASSIGNOR'S REPRESENTATIONS

(1) The Assignor represents and warrants that it is the lawful and exclusive registrant of the Domain Name and no other party has any right to

registration of the Domain Name or has otherwise made any claim to the Domain Name.

(2) The Assignor further represents and warrants that it has the exclusive authority to enter into this transaction and assign the Domain Name, free of the claims of any third parties, to the Assignee.

4. TRANSFER OF THE DOMAIN NAME

- (1) The Domain Name is registered with [insert Registrar's name] (hereinafter referred to as the "Registrar"), an ICANN accredited registrar system.

- iii. that the Domain Name and associated trademarks are free of any liens, security interests, encumbrances or licenses;
- iv. that the Domain Name or the associated trademark does not infringe the rights of any person or entity;
- v. that there are no claims, pending or threatened, with respect to Assignor's rights in the Domain Name or the associated trademarks;
- vi. that the Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

6. FURTHER ASSURANCES

9. FORCE MAJEURE

- (1) Force Majeure shall mean any event that is beyond the reasonable control of a Party, or the effects of which adversely affect the performance by such Party of its obligations under this Agreement, including, but not limited to, acts of God, sabotage, insurrection, terrorism, riots, hostilities or war (whether declared or not), acts of the public enemy, civil disturbances, any kind of fire, explosion, flood or accidental damage, epidemics, landslides, washouts, lightening, storms, earthquakes, lockouts, blockades, shortage of labor or material, major equipment failure, or other causes beyond the control of the Party affected.
- (2) Notwithstanding anything contained hereinabove, neither Party shall be liable to the other if it is unable to perform any of its obligations under this Agreement due to the occurrence of Force Majeure.
- (3) The Party affected by the Force Majeure event shall be entitled to suspend performance of its obligations under the Agreement to the extent that such performance is impeded or made impossible by the events of Force Majeure.
- (4) Each Party shall give a notice within [insert number] days of the occurrence of the event of Force Majeure and shall promptly thereafter

consult the other Party for the purpose of finding a mutually acceptable solution to the Force Majeure event.

10. INDEMNIFICATION

If either party is found to be in breach of this Agreement, the offending Party will indemnify the offended Party for any losses accrued as a result of the breach. Lost profits incurred as a result of any such breach shall be repaid by the offending Party to the offended Party.

11. SEVERABILITY

If a court of law finds any provision of this Agreement invalid or unenforceable at law for any reason, the remainder of this Agreement shall not be affected, and shall be interpreted so as best to effect the intent of the Parties.

12. AGREEMENT TO PERFORM NECESSARY ACTS

The Assignee and the Assignor hereby agree and undertake to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.

13. ENTIRE AGREEMENT

This Agreement, contains the entire understanding and agreement between the Parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof.

14. NONWAIVER

The failure of either Party to exercise any right provided in this Agreement shall not be construed as a waiver of its right to subsequently enforce such provision or any other provision of this Agreement.
