LEGAL SERVICES, SMEDA

The Legal Services (LS) department is a part of Business & Sector Development Services Division of the Small Medium Enterprises Development Authority and plays a key role in providing an overall facilitation and support to the small businesses. The LS believes that information dissemination among the small businesses on the existing legal & regulatory environment and business to business and business to client contracting is of paramount importance and plays a pivotal role in their sustainable development.

In order to facilitate small businesses, the LS, under the Pro-GOLE (Right to do business) project, a joint SMEDA-UNDP initiative for supporting the small businesses, has developed user-friendly contract templates.

Pro-GOLE, (Right to do Business)

The UNDP has partnered with the Small and Medium Enterprises Development Authority to initiate and execute the Pillar 4 (Right to do business) component of the UNDP PRO-GOLE project which seeks to enhance the legal awareness and mobility of marginalized/ informal businesses. Under the project legal services outreach shall be extended to small businesses including home based enterprises, small shopkeepers, growers, women entrepreneurs, hawking vendors etc. In addition, small business shall be mobilized to access legal services.

In an increasingly complex and competitive industry, it is vital that suppliers and purchasers are fully protected against legal and commercial risks. To counter such risks, a viable solution; available as- of the shelf commercial contract templates- will provide the users with first class ready to use support. AND WHEREAS the Service Provider is based in Pakistan and is engaged in the business of providing data punching services to its clients.

AND WHEREAS the Service Provider has represented to the Business that it possesses adequate resources, skills and qualifications to provide the Business with the Services, and based on the representations of the Service Provider, the Business has accepted the Services of the Service Provider.

NOW THEREFORE the Parties have entered into this Agreement on the following terms and conditions:

1. TERM

This Agreement shall come into effect on the date of execution of this Agreement, and shall continue to remain in force for a period of [insert number] months, unless terminated earlier by the Parties in accordance with the terms of this Agreement.

2. SERVICES

The Service Provider shall provide data punching services to the Business, which shall include copying the data from hard copies, in whatever format provided, in to electronic and editable formats.

The Business shall be responsible for providing the hard formats of the data to the Service Provider, whether by email, fax, or hard copies.

3. REMUNERATION

- (1) The Business shall pay to the Service Provider Rs. _____/- (Rupees ______) (insert amount) per [insert number] words of the data entered by the Service Provider in the performance of the Services under the Agreement (hereinafter referred to as the "Remuneration"). However, the Remuneration may be negotiable upon the receipt of the data by the Service Provider provided extraordinary effort is required in entering the data into soft format.
- (2) Upon the completion and acceptance by the Business of the data entered by the Service Provider, the Service Provider shall provide an invoice to the Business in accordance with Clause 3 (1).
- (3) The Business shall be liable to pay the Remuneration to the Service Provider within [insert number] days of the Service Provider providing the invoice to the Business.
- (4) The Remuneration shall be paid by the Business to the Service Provider in the [insert currency] equivalent of the amounts provided by Service Provider to the Business under Clause 3 (2).
- 4. TIMING AND ACCEPTANCE

- (1) The Service Provider shall prioritize performance of the Services as may be necessary or as agreed upon by the Parties, and will undertake commercially reasonable efforts to perform the Services with in such timelines as agreed between the Parties. The Business agrees to review the soft copies of the data (hereinafter referred to as the "Soft Data") within [insert number] days of the Service Provider's submission of the Soft Data to the Business, and to promptly either, (i) approve and accept the content so provided, in writing (which will then become the "Final Deliverables") or (ii) provide corrections sufficient to identify the Business's concerns, objections or corrections to the Service Provider.
- (2) In the absence of any such notice from the Business within the stated time period, the Soft Data shall be deemed accepted.
- (3) Once the Soft Data is accepted by the Business, the Service Provider shall not be liable for any mistakes in the data.
- 5. CONFIDENTIAL INFORMATION
- (1) Each Party acknowledges that in connection with this Agreement it may receive certain confidential or proprietary technical and business information and materials of the other Party, including, but not limited to, Preliminary Works (hereinafter referred to as the "Confidential Information"). Each Party, its agents and employees shall hold and maintain in strictest confidence all Confidential Information, shall not disclose Confidential Information to any third party, and shall not use any Confidential Information except as may be necessary to perform its obligations pursuant to this Agreement, or as may be required under the law. Notwithstanding the foregoing, Confidential Information shall not include any information that is in the public domain or becomes publicly known through no fault of the receiving party, or is otherwise properly received from a third party without an obligation of confidentiality.
- (2) Upon the completion of the Services under the Agreement, the Service Provider shall return to the Business all the materials provided by the Business to the Service Provider for the performance of the Services.
- 6. RELATIONSHIP OF THE PARTIES
- (1) Independent Contractor. The Service Provider is an independent contractor, not an employee of the Business or any company affiliated with the Business. The Service Provider shall provide the Services under the general direction of the Business, but the Service Provider shall determine the manner and means by which the Services are accomplished. This Agreement does not create a partnership or joint venture, and neither Party is authorized to act as agent or bind the other Party, except as expressly stated in this Agreement.
- (2) No Exclusivity. The Parties expressly acknowledge that this Agreement does not create an exclusive relationship between the Parties. The Business is free to engage others to perform services of the same or similar nature to those

provided by the Service Provider, and the Service Provider shall be entitled to offer and provide services to others, solicit other Businesses and otherwise advertise the services offered by the Service Provider.

7. TAXES

The Parties shall be liable to pay their own taxes applicable due to the performance of Services under this Agreement.

8. TERMINATION

(1) This Agreement may be terminated, with or without cause, at any time by either Party by giving the other Party a [insert number] days prior written notice.

(2) Upon expiration or termination of this Agreement:

- i. Each Party shall return or, at the disclosing Party's request, destroy the Confidential Information of the other Party; and,
- ii. Other than as provided herein, all rights and obligations of each Party under this Agreement, exclusive of the Services, shall survive.

9. GOVERNING LAW AND EXCLUSIVE JURISDICTION

This Agreement in all respects be read and construed and shall operate as a contract, in conformity with the laws of [insert country] and the courts at [insert place] shall have exclusive jurisdiction for adjudicating any dispute arising hereunder.

10. RESOLUTION OF DISPUTES

Any dispute, controversy or claim arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the UNCITRAL Arbitration Rules, subject to the exclusive jurisdiction of the Courts of [insert place].

11.FORCE MAJEURE

(1) Force Majeure shall mean any event that is beyond the reasonable control of a Party, or the effects of which adversely affect the performance by such Party of its obligations under this Agreement, including, but not limited to, acts of God, sabotage, insurrection, terrorism, riots, hostilities or war (whether declared or not), acts of the public enemy, civil disturbances, any kind of fire, explosion, flood or accidental damage, epidemics, landslides, washouts, lightening, storms, earthquakes, lockouts, blockades, shortage of labor or material, major equipment failure, or other causes beyond the control of the Party affected.

- (2) Notwithstanding anything contained hereinabove, neither Party shall be liable to the other if it is unable to perform any of its obligations under this Agreement due to the occurrence of Force Majeure.
- (3) The Party affected by the Force Majeure event shall be entitled to suspend performance of its obligations under the Agreement to the extent that such performance is impeded or made impossible by the events of Force Majeure.
- (4) Each Party shall give a notice within [insert number] days of the occurrence of the event of Force Majeure and shall promptly thereafter consult the other Party for the purpose of finding a mutually acceptable solution to the Force Majeure event.

12.AMENDMENTS

This Agreement may be modified, extended, enlarged or amended from time to time by mutual agreement and consent of the Parties.

13.NONWAIVER

The failure of either Party to exercise any right provided in this Agreement shall not be construed as a waiver its right to subsequently enforce such provision or any other provision of this Agreement.

14.NON-ASSIGNMENT

In no circumstances whatsoever can a Party assign the benefit of this Agreement to any third person or delegate to a third person its duties to be performed under this Agreement, unless with the written consent of the Parties. 15.PARTIAL INVALIDITY

If any provision of this Agreement is held by a Court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions shall nevertheless continue in full force and effect without being impaired or invalidated in any way.
