The Need for Commercial Contracts Templates



Co-Branding Agreement for Marketing



Between

1. ABC, is a marketing company incorporated in ----- (country name) and having its principal office/s at ----- (address),

WHEREAS

ABC Company operates a website through which it offers marketing and selling services.

XYZ, Company is a company engaged in the business of production and selling of clothing and fashion wear.

WHEREAS, the XYZ Company desires to acquire marketing services by cobranding with the ABC Company to enable the customers to purchase its products through ABC Company's website.

NOW THEREFORE, in consideration of the mutual promises contained herein, the parties, intending to be legally bound, agree as follows:

1. Co-Branding:-

Subject to the terms and conditions of this Agreement, ABC Company agrees to provide marketing services through its website to promote XYZ Company's products for sale under a co-brand.

2. Linking Services:-

- **2.1**. ABC Company agrees to incorporate and display the graphical image file and/or trade name or mark provided by XYZ Company on its website as a cobrand product.
- **2.2.** Under this Agreement, ABC Company shall be entitled to get consideration of Rs. /\$ ------ per month or per year against the total sum of Rs. /\$ -----in mutually agreed form of payment.

3. Grant of Airtime on Website:-

3.1. ABC Company shall grant to XYZ Company, airtime on the ABC Company's website for a period of ------ years from the date of commencement of such service provided that such commencement shall begin no later than day------ month, ------ year. ABC Company, represents and warrants to XYZ Company that the information contained in this agreement is true, complete and accurate in all material aspects.

6.2 Representations and Warranties by XYZ Company:

XYZ Company represents and warrants to ABC Company, that the information contained in this agreement is true, complete and accurate in all material aspects and that this agreement constitutes legally binding obligations for ABC Company.

6.2.1 Both the Companies have the power to enter into and perform this Agreement and this Agreement has been duly authorized and executed by, and constitute legally binding obligations for both the companies.

7. Confidentiality:-

Neither of the parties hereto shall divulge to any person (other than its officers, employees and professional advisors on a need to know basis) or use for any purpose any of the trade secrets or confidential information or any financial or trading information relating to the other party which it acquires as a result of entering into this agreement whether directly or indirectly. Each of the parties shall ensure to prevent its employees from doing anything which, if done by the party, would be a breach of this agreement. This restriction shall continue to apply after the expiration or termination of this Agreement without limit in point of time but shall cease to apply to secrets or information which come into the public domain through no fault of the party concerned. If there is any requirement of any Government or Regulatory Authority for disclosure of information and/or making of any announcement, the relevant party shall notwithstanding the provisions of this agreement be entitled to comply with such requirement but shall consult the other party.
