- (1) The Assignor does hereby irrevocably assign to the Assignee all rights, title, and interest (including but not limited to all registration rights with respect to the Patents, all rights to use the patent for commercial gains and other purposes, all goodwill and all other rights in and to the Patents.
- (2) The Assignor agrees to provide the Assignee with any and all documents related to the Patents, plans, written works, etc. This transfer shall begin upon the signing of this Agreement, and shall be completed no later than [insert number] days past the signing of the Agreement.

2. CONSIDERATION

- (1) The Assignee shall transfer the ownership, rights and title in the Patents to the Assignor against a consideration of Rs. ____/- (Rupees _____) (insert amount) (hereinafter referred to as the "Consideration") to be paid by the Assignee to the Assignor.

3. REPRESENTATIONS AND WARRANTIES

(1) The Assignor represents and warrants to the Assignee:

- i. that the Assignor has the right, power and authority to enter into this Agreement;
- ii. that the Assignor is the exclusive owner of all right, title and interest, including all intellectual property rights, in the Patents;
- iii. that the Patents are free of any liens, security interests, encumbrances or licenses;
- iv. that the Patents do not infringe the rights of any person or entity;
- v. that there are no claims, pending or threatened, with respect to Assignor's rights in the Patents;
- vi. that the Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

4. GOVERNING LAW AND EXCLUSIVE JURISDICTION

This Agreement in all respects be read and construed and shall operate as a contract, in conformity with the laws of Pakistan and the courts at [insert place] shall have exclusive jurisdiction for adjudicating any dispute arising hereunder.

5. RESOLUTION OF DISPUTES

Any dispute, controversy or claim arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the Pakistan Arbitration Act, 1940, subject to the exclusive jurisdiction of the Courts of [insert place].

6. FORCE MAJEURE

- (1) Force Majeure shall mean any event that is beyond the reasonable control of a Party, or the effects of which adversely affect the performance by such Party of its obligations under this Agreement, including, but not limited to, acts of God, sabotage, insurrection, terrorism, riots, hostilities or war (whether declared or not), acts of the public enemy, civil disturbances, any kind of fire, explosion, flood

- or accidental damage, epidemics, landslides, washouts, lightening, storms, earthquakes, lockouts, blockades, shortage of labor or material, major equipment failure, or other causes beyond the control of the Party affected.
- (2) Notwithstanding anything contained hereinabove, neither Party shall be liable to the other if it is unable to perform any of its obligations under this Agreement due to the occurrence of Force Majeure.
 - (3) The Party affected by the Force Majeure event shall be entitled to suspend performance of its obligations under the Agreement to the extent that such performance is impeded or made impossible by the events of Force Majeure.
 - (4) Each Party shall give a notice within [insert number] days of the occurrence of the event of Force Majeure and shall promptly thereafter consult the other Party for the purpose of finding a mutually acceptable solution to the Force Majeure event.

7. INDEMNIFICATION

If either party is found to be in breach of this Agreement, the offending Party will indemnify the offended Party for any losses accrued as a result of the breach. Lost profits incurred as a result of any such breach shall be repaid by the offending Party to the offended Party.

8. AMENDMENTS

This Agreement may be modified, extended, enlarged or amended from time to time by mutual agreement and consent of the Parties.

9. SEVERABILITY

If a court of law finds any provision of this Agreement invalid or unenforceable at law for any reason, the remainder of this Agreement shall not be affected, and shall be interpreted so as best to effect the intent of the Parties.

10. AGREEMENT TO PERFORM NECESSARY ACTS

The Assignee hereby agrees and undertakes to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.
